5. Person-centred approach resources

A discussion tool place regarding what person-centred resources might look like and how these resources could also potentially be developed into a more tangible project. Out of this discussion the following ideas regarding the way forward were raised:





- The group will continue to produce an online resource that will be geared towards being consciousness raising rather than prescriptive in nature (see examples attached).
- Traci put forward the idea of creating a 'service passport' for clients. This would be a document/booklet that clients could use to record service information, for example, the names of the agencies and people at those agencies that they work with. Working group members to begin thinking about what key features a resource of this kind might have e.g. person-centred tag line.
- To work on a project that would be of benefit, for example, to the family and DV sector, NDIS or mental health we would need to be responding to an identified need. We therefor need to engage with individuals working within these sectors to establish if such a need exists.

Actions

- Traci, Jennie, Katarina and Heather to canvass opinion from clients on the value of a 'service passport' and what features should be incorporated.
- Jennie will set up a meeting with Russel Smith (NDIS-My Way) and Anne Moore (Lucy Saw Centre) to gauge their interest in us potentially doing a project within these areas.
